I AGREE that I choose to participate voluntarily in the competition with or without my horse, as a rider, handler, spectator, leasor, lease, owner, agent, coach/trainer or as a parent or guardian of a junior exhibitor and I am fully aware and acknowledge that horse sports and the Competition involves inherent dangerous risks of accident, loss and serious bodily injury including broken bones, head injuries, trauma, pain, suffering or death (Harm).

I AGREE, to release the HSITP, LLC, Jeanne and Page Winslow and the competition from all claims for money, damages or otherwise for any Harm to the horse or me and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the HSITP, LLC, it's officers/directors, owners, designates, contractors or the Competition.

I AGREE, to expressly assume all risks of Harm to me or my horse, or those individuals and or animals I may have responsibility for or have signed this document as trainer/parent/legal guardian or owner, including Harm resulting from the negligence of the HSITP, LLC or the Competition

I AGREE to indemnify( pay any losses, damages, or costs incurred by) the HSITP, LLC and the Competition and to hold them harmless with respect to claims for Harm to me or my horse and for claims made by others for any Harm caused by me or my horse at the Competition.

I HAVE READ the HSITP, LLC and Competition rules about protective equipment and I understand that I am entitled to wear protective equipment without penalty.
