The construction and application of the EMR, LLC, HSITP,LLC rules are governed by the laws of the State of Florida and any action instituted against HSITP, LLC or Page and Jeanne Winslow must be filed in Florida.

EMR, LLC, HSITP LLC RELEASE, ASSUMPTION OF RISK, WAIVER AND INDEMNIFICATION: I AGREE, in consideration for my participation in the Competition to the following:

I AGREE that I choose to participate voluntarily in the competition with or without my horse, as a rider, handler, spectator, leasor, lease, owner, agent, coach/trainer or as a parent or guardian of a junior exhibitor and I am fully aware and acknowledge that horse sports and the Competition involves inherent dangerous risks of accident, loss and serious bodily injury including broken bones, head injuries, trauma, pain, suffering or death (Harm).

I AGREE, to expressly assume all risks of Harm to me or my horse, or those individuals and or animals I may have responsibility for or have signed this document as trainer/parent/legal guardian or owner, including Harm resulting from the negligence of the EMR, LLC; HSITP,LLC or the Competition

I AGREE to indemnify( pay any losses, damages, or costs incurred by) the EMR, LLC; HSITP,LLC and the Competition and to hold them harmless with respect to claims for Harm to me or my horse and for claims made by others for any Harm caused by me or my horse at the Competition.
