Showing horses receive priority for limited stabling. All horses in a stall must show in a full division for 2 DAYS, or a \$55 non-showing fee will be added each day plus show fees. Due to limited stabling or large show size, tack stalls may be limited. Tack stalls in temporary stabling are charged the full price of the stall to the show per stall (approx. \$160) & split among the riders in that barn if desired.
